First Assembly Session

The 75th ACYOA General Assembly of the Armenian Church Youth Organization of America convened on Friday, May 27, 2022 at **9:12 AM**.

Roll Call-Confirmation of Ouorum

Sona Dagley (Central Council) took roll call.

Housekeeping

Mary Keutelian (St. Gregory, Chicago, IL) introduced herself as the 2021 Chair of the Day. She presented housekeeping notes and an introduction of Robert's Rules of Order.

Election for Chairperson and Vice Chairperson

Mary Keutelian (St. Gregory, Chicago, IL) welcomed the nominating committee to speak and present the nominees for Chair and Vice Chair of the Day. Natalie Mardoian (Nominating Committee) and Alex Dayeian (Nominating Committee) mentioned that Mary Keutelian offered to be Chair of the Day. Natalie asked if anyone from the floor had a nomination for the second slot on the ballot. Natalie explained that whoever has the most votes would be elected Chair of the Day and whoever has the second most votes would be the Vice Chair of the Day. Fr. Andreas Garabedian (St. Gregory, Chicago, IL) nominated Alex Dayenian.

Stephen Hollisian (Holy Trinity, Cambridge, MA) seconded the nomination. Alex accepted the nomination.

Mary Keutelian (St. Gregory, Chicago, IL) motioned to close nominations, Sona Dagley (Central Council) seconded the motion. The motion passed.

Mary Keutelian (St. Gregory, Chicago, IL) appointed Jordan Reid (St. Mesrob, Racine, WI) and Mara Najarian (St. John, Southfield, MI) to be Sergeant of Arms during this election.

Sona Dagley (Central Council) took the roll call. There were 38 delegates present to vote. Mary Keutelian (Chair of the Day) stated that delegates were allowed to vote for the Chair of the Day via paper ballot.

Fr. Aren Jebejian (St. John, Southfield, MI) mentioned that members of the auditing committee can help to count the ballots. Zaven Dadian (St. John, Southfield, MI) stepped outside to assist.

Mary Keutelian (Chair of the Day) asked the Sergeant of Arms to stand by the doors.

Election results:

Natalie Mardoian (Nominating Committee) announced the election results. Mary Keutelian (St. Gregory, Chicago, IL) was elected Chair of the Day and Alex Dayenian (St. George, Waukegan, IL) was elected as Vice Chair of the Day.

Adopting of Agenda

Mary Keutelian (Chair of the Day) asked if there is a motion to approve the meeting minutes. Yn. Lucine Sabounjian (Holy Resurrection, New Britain, CT) made the motion to accept the agenda. Stephen Hollision (Holy Trinity, Cambridge, MA) seconded the motion.

Mary Keutelian (Chair of the Day) asked if there was a motion to approve the meeting minutes. Fr. Andreas Garabedian (St. Gregory, Chicago, IL) made a motion to approve the 2022 meeting minutes. Stephen Hollision (Holy Trinity, Cambridge, MA) seconded the motion.

Election for Central Council

9:30 AM - Natalie Mardoian (Nominating Committee) presented the slate of candidates. She stated that Melissa Fanizza (Central Council) was conducting the vote through Election Buddy. There must be six people running for each ballot, and the floor was open for additional nominations.

Jordan Reid (St. Mesrob, Racine, WI) nominated Lucine Boloyan (St. James, Watertown, MA), and she respectfully declined.

Melissa Fanizza (Central Council) nominated Zaven Dadian (St. John, Southfield, MI). Fr. Aren Jebejian (St. John, Southfield, MI) seconded, and Zaven respectfully declined.

Fr. Andreas Garabedian (St. Gregory, Chicago, IL) moved to close nominations, and Nora Knadjian (St. Gregory, Chicago, IL) seconded. Rafael Grigoryan (Central Council) declined moving forward as Rita Katanjian (St. Sarkis, Dallas, TX) and Vatche Kajadian (St. Sarkis, Dallas, TX) had Mardig Klachian (St. Sarkis, Dallas, TX) on the phone, and he wished to be nominated for the Central Council.

Vatche Kajadian (St. Sarkis, Dallas, TX) nominated Mardig Klachian (St. Sarkis, Dallas, TX), Sona Dagley (Central Council) seconded it. He accepted the nomination over the phone.

Fr. Andreas Garabedian (St. Gregory, Chicago, IL) moved to close nominations, and Nora Knadjian (St. Gregory, Chicago, IL) seconded. Nominations were closed by Mary Keutelian (Chair of the Day).

Alex Dayenian (Nominating Committee) invited Melissa Fanizza (Central Council) to the podium to explain the voting process. Melissa stated that this voting program, Election Buddy, was previously used at the 2021 Virtual General Assembly. She stated that an email message would be sent with an invitation to vote. There were a total of four vacancies on the Central Council.

9:45 AM - Melissa Fanizza (Central Council) asked for a roll call to take place. Sona Dagley (Central Council) started the roll call. Mary Keutelian (Chair of the Day) introduced the current Central Council before the vote took place.

9:56 AM - Melissa Fanizza (Central Council) stated that there were 36 voters, so there must be 19 or more votes. The Election Buddy email was sent to all voters, who had five minutes to cast their votes. She stated that the voters were able to choose 1, 2, 3, or 4 candidates.

10:04 AM - Melissa Fanizza (Central Council) closed the vote.

ACYOA Bylaws Committee / Proposed Bylaws

10:05 AM - Melissa Fanizza (Central Council) introduced the history of recently proposed bylaws, as well as the newly formed ACYOA Bylaws Committee. The Bylaws Committee started work in 2020 and appeared at this General Assembly meeting to propose revisions to the bylaws.

Talin Hitik, Esq. (Bylaws Committee Chair) appeared on Zoom to present the proposed revisions.

10:37 AM - Mary Keutelian (Chair of the Day) opened the floor for discussion.

Fr. Aren Jebejian (St. John, Southfield, MI) requested that any changes be made before voting on the final bylaws document, because the document belongs to this General Assembly.

Stephen Hollisian (Holy Trinity, Cambridge, MA) asked about Article 15, for the restructuring of the ACYOA parish chapters. If there are not five members in the individual church ACYOA chapters, a regional ACYOA group may be established by the Central Council. The Central Council has never decided to dissolve an ACYOA chapter in the past.

Ben Tavitian (Hye Pointe, Haverhill, MA) asked if a regional chapter is the only governing body that will manage the chapter. Talin Hitik (Bylaws Committee Chair) answered that she anticipates a regional chapter will be managed with the guidance of Central Council and an appointed priest, and that all of the parishes will also serve to assist with the regional groups. The membership and funding will be equitable.

Lucine Boloyan (St. James, Watertown, MA) seconded Fr. Aren Jebejian's motion to make changes on the floor. She read Article 4 Section 3.1 and Article 7, Section 4, as there were grammatical errors in the bylaws.

Jennifer Morris (DYYAM) asked to offer a point of knowledge. Jennifer mentioned how in law's modern American English, "they" is used rather than "he/she". Talin Hitik, Esq. (Bylaws Committee Chair) said that is how she modernizes legal contracts, and "they" is taken in context as to whether it is singular or plural.

Fr. Avedis Kalayjian (St. Mesrop, Racine, WI) stated that there is no language in the bylaws about a three fourths vote, except for the dissolution of ACYOA. The General Assembly can do with the document as it will before it is voted on.

Alex Dayenian (St. George, Waukegan, IL), made a motion to accept the proposed bylaws in its entirety and requested a vote to follow up afterward.

Fr. Aren Jebejian (St. John, Southfield, MI), said that is not the proper way to proceed. The motion was not seconded and denied, as it was out of order.

Stephen Hollisian (Holy Trinity, Cambridge, MA) pointed out Article 5 Section 3 (Campus Creations), and mentioned that college campuses may make it difficult for the ACYOA to create a religious organization on a college campus. Talin Hitik, Esq. (Bylaws Committee) mentioned that it is up to the college group's discretion.

Mary Keutelian (Chair of the Day) asked Lucine Boloyan (St. James, Watertown, MA) to come forward and re-state her amendment. Lucine asked that anywhere in the document "they" be changed to "he/she". Examples were noted in Article 4 Section 3.1 and Article 7, Section 4. Talin Hitik, Esq. (Bylaws Committee Chair) highlighted where in the Bylaws document that the language would be changed and read the changed language aloud to the Assembly. Mary Keutelian (Chair of the Day) asked if there is a second for the proposed amendment. Fr. Avedis Kalayjian (St. Mesrob, Racine, WI) seconded the motion. The floor opened for discussion of the amendment. Melissa Fanizza (Central Council) mentioned how language is used in the school system, as she is a teacher. She mentioned how they/them/their is part of modern verbiage. There was no other discussion on the proposed amendment.

Mary Keutelian (Chair of the Day) asked if there was a proposal to close the discussion of the amendment. Stephen Hollisian (Holy Trinity, Cambridge, MA) motioned to close the discussion, and Ben Tavitian (Hye Pointe, Haverhill, MA) seconded the motion. Melissa Fanizza (Central Council) continued the discussion, and pointed out to change Section 6 to Section 5.

Stephen Hollisian (Holy Trinity, Cambridge, MA) asked for clarification on Article 5 in its entirety. He discussed the process of speaking with university administration and how it works with a religious organization. He pointed out that with stewardship, a portion would be donated to the Central Council. Universities have strict rules about how funds can be distributed, and can restrict funding if you donate that money to the higher organization. Talin Hitik, Esq. (Bylaws Committee) clarified that the campus group does not need to organize with a college campus. There may be advantages and disadvantages to registering at a college or university. However, every member of the campus group is also a member of the ACYOA chapter.

Mary Keutelian (Chair of the Day) asked if there was a motion to end the discussion. Ben Tavitian (Hye Pointe, Haverhill, MA) made a motion and Jordan Reid (St. Mesrob, Racine, WI) seconded it. The motion was passed unanimously.

Mary Keutelian (Chair of the Day) asked if we could vote on accepting the Bylaws. Fr. Aren (St. John, Southfield, MI) made a motion to accept the Bylaws, and Sona Dagley (Central Council) seconded it. The motion passed with 30 affirmatives out of 38.

Fr. Aren Jebejian (St. John, Southfield, MI), thanked Talin, the Bylaws Committee members, and the ACYOA General Assembly attendees for taking part in a historical moment to revise the Bylaws for our organization. The last time a revision took place was eleven years ago.

Sona Dagley (Central Council) noted that these bylaws need to be voted on again at the next Assembly, so they are not revised at this time.

Talin Hitik, Esq. (Bylaws Committee Chair) thanked the Central Council and stated it was a privilege to have a solution for the ACYOA chapter structure. She was grateful to everyone for being forward-thinking.

Mary Keutelian (Chair of the Day) invited the Nominating Committee to the podium to share the results of the Central Council election.

11:15 AM - Alex Dayenian (St. George, Waukegan, IL) shared the Central Council election results:

11:16 AM - Mary Keutelian (Chair of the Day) invited the V. Rev. Fr. Mesrop Parsamyan, Primate-Elect, to speak. He discussed how ACYOA continued and adopted its programs during the uncertain times of COVID, and how they served above and beyond their own expectations. He mentioned the newly consecrated St. Sarkis church, and how there is room for both old and new to bring unique beauty into the world. He concluded by speaking about his experience serving as a priest to a church in the Midwest, and how this shaped his understanding of the Eastern Diocese.

11:30 AM - Mary Keutelian (Chair of the Day) thanked the parish members for being present at the General Assembly.

Mary Keutelian (Chair of the Day) asked if there was a motion to close the floor. Sona Dagley (Central Council) made the motion to close the floor. Stephen Hollisian (Holy Trinity, Cambridge, MA) seconded the motion. The motion passed.

Election for Auditing Committee

Natalie Mardoian (Nominating Committee) introduced the current Auditing Committee ballot, including:

Shant Der Torossian (St. James, Watertown, MA) nominated Stephen Hollisian (Auditing Committee). Mary Keutelian (Chair of the Day) seconded the motion of the nomination. Stephen Hollisian accepted the nomination.

Melissa nominated Ben Tavitian (Hye Pointe, Haverhill, MA), and Yn. Lucine Sabounjian (Holy Resurrection, New Britain, CT) seconded the nomination. Ben Tavitian (Hye Pointe, Haverhill, MA) accepted.

Stephen Hollisian (Holy Trinity, Cambridge, MA) nominated Shant Der Torossian (St. James, Watertown, MA), and Shant declined.

Andrew Yenicag (Central Council) nominated Chris Artun (Holy Martyrs, Bayside, NY) and Rafael Grigoryan (Central Council) seconded the nomination. Chris accepted the nomination.

Vatche Kajadian (St. Sarkis, Dallas, TX) nominated Rita Katanjian (St. Sarkis, Dallas, TX), and Yn. Lucine Sabounjian (Holy Resurrection, New Britain, CT) seconded. Rita accepted.

Fr. Aren Jebejian (St. John, Southfield, MI) asked if we could vote with plurality rather than a majority vote. Melissa Mardoian (Central Council) seconded the motion and the motion

passed by a vote.

Melissa Fanizza (Central Council) explained how the Election Buddy poll would work for the Nominating Committee and Auditing Committee.

Ben Tavitian (Hye Pointe, Haverhill, MA) stepped in as a back-up Sergeant of Arms, as Jordan Reid (St. Mesrob, Racine, WI) could not be found.

11:43 AM - Sona Dagley (Central Council) took roll call for the election. There were 36 delegates present to vote.

11:49 AM - Melissa Fanizza (Central Council) came to the podium to point out that Lucine Boloyan (St. James, Watertown, MA) asked to remove herself from the ballot, and that there was still a full slate. Melissa noted that the maximum number of candidates would be up to 3 for Nominating Committee and up to 3 for Auditing Committee.

11:57 AM - Mary Keutelian (Chair of the Day) asked if there was a motion to recess for lunch. Sona Dagley (Central Council) made a motion and Andrew Yenicag (Central Council) seconded the motion.

2021 ACYOA Central Council Report

1:36 PM - Mary Keutelian (Chair of the Day) invited Sona Dagley (Central Council) to present the ACYOA Annual Report.

Sona Dagley (Central Council) thanked her fellow Central Council members for their continued dedication. Throughout the year, ACYOA found ways to gather in Christ through outdoor activities, Zoom discussions, etc. The Central Council met on Zoom once per month until they decided to have in-person meetings, and held two in-person Bishop's 5Ks. The 75th Anniversary of 2021 was pushed back to 2022, and due to life circumstances, the co-chairs sent in letters of designation and turned it over to the ACYOA Central Council. It will take place on September 17, 2022 in Fair Lawn, NJ. They continued to promote Summertime Service, and also, created a virtual ASP trip. Retreats were held in a smaller setting, as well as Zoom discussions (Sunday Scripture, Monday Meditation, and Diving Deep). Sona opened the floor for any questions or remarks.

Melissa Fanizza (Central Council) asked if her last name could be changed to Fanizza and if Ani Misirliyan's last name could be spelt correctly.

Fr. Krikor Sabounjian (Holy Translators, Framingham, MA) said that Sona has taken her job very seriously.

Fr. Aren Jebejian (St. John, Southfield, MI), remarked that everyone stepped up and came up with innovative ideas. He also mentioned the ACYOA 75 Year Anniversary and asked why the committee resigned. Sona replied that the previous committee committed prior to COVID and could no longer commit their time to this project. Jennifer Morris (DYYAM) pointed out that there is a line item on the agenda to discuss the 75+1 Anniversary.

Lucine Boloyan (St. James, Watertown, MA) thanked ACYOA for everything they had planned in person as well as through creative online outlets.

Mary Keutelian asked if anyone would make a motion to close discussion. Ben Tavitian (Hye Pointe, Haverhill, MA) made the motion, and Jordan Reid (St. Mesrob, Racine, WI) seconded it.

2021 Department of Youth and Young Adult Ministries Report

Mary Keutelian (Chair of the Day) invited Jennifer Morris (DYYAM) to present the 2021 Department of Youth and Young Adult Ministries Report. Jennifer stated that she and Kat need the help of ACYOA for camp this summer since it was online for two years. They are looking for lifeguards and counselors. Additionally, Jennifer noted that the junior chapters flourish at the parish levels, and they want to grow that to the senior chapters, as well. Jennifer opened the floor to questions.

2:00 PM - Fr. Ghevond Ajamian (St. Sarkis, Dallas, TX) mentioned that the ASP price has gone up drastically. There is a \$4,100 fee per participant, but there is also a \$10,000 grant from the Dadourian Foundation. The first 20 participants received a scholarship, but they will have about

six more participants, so grassroots fundraising is currently taking place right now.

- **2:02 PM** Melissa Fanizza (Central Council) mentioned that Jennifer Morris (DYYAM) puts together so many pieces and pushes everyone, and she cannot imagine having anyone else lead the Central Council.
- **2:03 PM** Alex Dayenian (Nominating Committee) spoke of his ASP trip. He asked if there are other plans in the future to get involved with Artsakh. Jennifer Morris (DYYAM) mentioned that all of the funds from the Bishop's 5K went towards the Artsakh Relocation Project.
- **2:06 PM -** Yn. Lucine Sabounjian (Holy Resurrection, New Britain, CT) asked about the reaction to Sunday Scriptures. Jennifer Morris (DYYAM) said ACYOA Juniors do not often log on. She suggested that the Seniors let the Juniors know the sessions are taking place so they participate in future sessions. She thanked last year's Central Council and the outgoing members of this year's Central Council.

Mary Keutelian (Chair of the Day) asked if there was a motion to close the discussion. Rita Katanjian (St. Sarkis, Dallas, TX) made a motion to close the discussion, and Lucine Boloyan (St. James, Watertown, MA) seconded the motion. The motion passed.

Small Group Discussions

Melissa Fanizza (Central Council) and Ani Misreliyan (Central Council) said that everyone was to be broken up into small group discussions for thirty minutes.

- **2:57 PM** Ben Tavitian (Hye Pointe, Haverhill, MA) noted that engagement numbers are dwindling. With COVID, a lot of things became remote and people have found other activities to fill their time. He proposed that ACYOA Juniors and Seniors connect through a more down-to-Earth event so the Juniors can see "this is us."
- **2:59 PM -** Shant Der Torossian (St. James, Watertown, MA) commented that the transition from ACYOA Juniors to Seniors is the age range where they lose people, but mentorship from high school to college, as well as fostering connections, can be beneficial. His parish successfully mentored ACYOA Juniors in the past.
- **3:01 PM** Rita Katanjian (St. Sarkis, Dallas, TX) recalled that when their ACYOA Senior chapter was dying out, one of their community members made a three and five year plan for hosting Sports Weekend. It gave them something to work towards and get excited about, and ultimately, this is why their ACYOA Senior chapter is as strong as it is right now.
- **3:03 PM** Aline Tashjian (St. Leon, Fair Lawn, NJ) noted that every summer, their ACYOA chapter hosts "Beach and Badarak" with a sister church, St. Stepanos. The community members attend Badarak in the morning and then go to the beach afterwards with a barbeque. She suggested that perhaps for a long weekend, one of the warmer weather parishes could cost parishes during the winter months.

2021 Auditing Committee Report

3:08 PM - Mary Keutelian (Chair of the Day) invited Zaven Dadian (Auditing Committee) and Stephen Hollisian (Auditing Committee) to present the 2021 Auditing Report. Zaven stated that the committee reviewed the 2021 Financial Report. There were no questions. Fr. Andreas Garabedian (St. Gregory, Chicago, IL) motioned to accept the report, and Nora Knadjian (St. Gregory, Chicago, IL) seconded the motion. The motion passed.

2021 Financial Report

3:11 PM - Mary Keutelian (Chair of the Day) invited Rafael Grigoryan (Central Council) to present the 2021 Financial Report. He reiterated the duties of his position, and presented the financial information. No questions were asked. Sona Dagley (Central Council) motioned to close, and Aline Tashjian (St. Leon, Fair Lawn, NJ) seconded the motion. The motion passed.

New Business

Review 2022 Approved Budge/Review and Vote on 2023 Proposed Budget

3:17 PM - Rafael Grigoryan (Central Council) presented the 2022 approved budget, as well as the proposed 2023 budget.

Ben Tavitian (Hye Pointe, Haverhill, MA) asked about the 2019 website line, and how do we expect to be paying less in 2023? Arsen Yelegen donated his time to help redo the website.

Ben Tavitian (Hye Pointe, Haverhill, MA) asked how stewardship will be adjusted in 2024. Rafael Grigoryan (Central Council) said that will be discussed further next year at the 2023 General Assembly. Sona Dagley (Central Council) said that next year's dues will be for 2022.

Lucine Boloyan (St. James, Watertown, MA) asked that since Central Council meetings were conducted Zoom during Covid, will that affect what is spent on these meetings going forward? Rafael Grigoryan (Central Council) said it was easier to join Zoom, but the in-person element was missing to work through problems together. He said it will be on a case-by-case basis, but the approach going forward will be in-person meetings. Melissa Fanizza (Central Council) commented that meeting with the parishes provides an additional piece other than meeting with each other.
